## **CONTRIBUTORS**

- Didier Davin is Associate Professor at the National Institute of Japanese Literature. His research interests center on the doctrinal and cultural history of the Japanese Rinzai branch of Zen. His recent publications include "Between the Mountain and the City: Ikkyū Sōjun and the Blurred Border of Awakening" (*Studies in Japanese Literature and Culture*, 2), "Zen to haiku: Sutereotaipu no sai kentō" (*Sōgō Kenkyū Daigakuin Daigaku*, 38), and "Muromachi jidai no zensō to *Rinzairoku*" (*Rinzairoku kenkyū no genzai*, 2017).
- James Fujitani is Associate Professor in the Department of Modern Languages at Azusa Pacific University. His specialization is the history of East-West relations, with particular focus on Portuguese interactions with Ming China and Sengoku Japan. He is currently preparing a monograph on the first diplomatic contact between Portugal and China in 1517, under contract with Amsterdam University Press.
- Gwendolyn Gillson is Assistant Professor of Asian studies at Illinois College. Drawing on transnational feminism, affect theory, and the concept of lived religion, her research explores the effects of global economic and social change on the concepts of religion, gender, and community. Her current project examines how Buddhist nuns and laywomen form deep and spiritually meaningful bonds with one another through shared affective and embodied experiences in order to create both intimate and transnational networks of Buddhist women.
- Helen Hardacre has taught at Harvard University since 1992, where her research and teaching address Japanese religious history of the modern period. She has conducted ethnographic studies of Shinto shrines and new religious movements, lay Buddhist organizations, the religious life of Japan's Korean minority, and ritualizations of abortion. She has also researched the history of Shinto. Her current research centers on three projects: public funding for Shinto shrines from 1906 to 1945, constitutional revision in Japan, and Japanese enthronement ritual. She was awarded the Order of the Rising Sun in 2018.
- INOUE Nobutaka is Professor Emeritus at Kokugakuin University and Director of the Religious Information Research Center. His specializations are the sociology and cognitive science of religion, and he is presently promoting

religious culture education in Japanese higher education. His recent publications include New Religions in the Age of Mass Media (Kokugakuin University, 2017), Contemporary Japanese Religion (Foreign Press Center/ Japan, 2000), "New Religious Movement in Global context" (In Controversies in Contemporary Religion: Education, Law, Politics, Society, and Spirituality, vol. 3, ed. Paul Hedge, Praeger, 2014), and "Media and New Religious Movements in Japan" (Journal of Religion in Japan 1).

- Erez Joskovich teaches in the Department of Philosophy at Ben-Gurion University of the Negev and the Department of East Asian Studies at Tel Aviv University. He specializes in the intellectual and religious history of Chan/ Zen Buddhism, with a focus on the development of Japanese Rinzai from the eighteenth century to the present. His recent publications include "Playing the Patriarch: Representation and Transformation in the Zen Sermon" (Journal of the American Academy of Religion 85) and "The Inexhaustible Lamp of Faith: Faith and Awakening in the Japanese Rinzai Tradition" (Japanese Journal of Religious Studies 42).
- Masato KATO researches the negotiation of cultural identity of Japanese religions in overseas contexts through the case of Tenrikyō. He is currently a Postdoctoral Research Associate at the Centre for the Study of Japanese Religions, soas University of London. His article based on his doctoral research is forthcoming in the Journal of Contemporary Religion.
- George Klonos is an independent researcher of East Asian religions. His previous position was as Director of Antioch Education Abroad's program on Japanese Buddhism in Kyoto. His research interests include Shugendo, sacred geographies, and Esoteric Buddhism in the early modern period. He is currently working on a monograph on En no Gyōja, the founder of Shugendo.
- Esben Petersen is Research Fellow at Nanzan Institute for Religion and Culture. His research focuses on the history of the liberal-Protestant missionaries belonging to the Swiss and German mission society, the Allgemeine Evangelisch-Protestantische Missionsverein. He is currently working on his PhD dissertation, which focuses on the missionaries' role in the cultural production of "religion" in late nineteenth-century Japan.
- Karli Shimizu is a PhD candidate in the Graduate School of Education, Hokkaido University. Her research interests are centered on modern Shinto shrines and secularism. She is currently working on her dissertation, which focuses on overseas Shinto shrines and their relation to secularity, modernity, and imperialism. Her publications include "Shintō Shrines and Secularism in Modern Japan, 1890-1945" in the Journal of Japanese Religion 6 (2017).
