CONTRIBUTORS

Ethan BUSHELLE is Assistant Professor of East Asian Culture and Religions in the Department of Global Humanities and Religions at Western Washington University. His research explores the role Buddhism played in shaping Japanese understandings of the self, society, and cosmos from the classical through medieval periods. His recent publications include “Mountain Buddhism and the Emergence of a Buddhist Cosmic Imaginary in Ancient Japan” (*JJRS* 45/1).

Frank CLEMENTS is a Tianzhu Charitable Foundation Postdoctoral Fellow in East Asian Buddhism at the University of British Columbia. His research focuses on the Shugendo of northern Japan, particularly *shugenja* households affiliated with Haguro Shugendo. His current project explores how these households were embedded in the economic, social, and political contexts of the village community.

Michael CONWAY is Lecturer in the Shin Buddhist Studies Department at Otani University. His research focuses on the Chinese predecessors to Shinran’s Pure Land thought as well as modern Japanese engagement with it. His works include “Dharmākara as the Subject, Not Object of Faith: The Reinterpretation of Amida’s Causal Phase in Modern Shin Thought” (In *Faith in Buddhism*, Imre Hamar and Takami Inoue, eds., 2016).

Ralph H. CRAIG III is a PHD student in Religious Studies at Stanford University, where he specializes in Buddhism with a focus on early South Asian Buddhism and American Buddhism. His research interests include comparative religion, religion and popular culture, literature, and African-American Studies.

Alise Eishō DONNERE teaches English at Tohoku Gakuin University and Russian at NHK Culture Center, while continuing her research on Jizō and other imagery used at modern Buddhist temples. Her academic interests include modern temple Buddhism, the role of non-Japanese nationals in Japanese religions, and the history of religion in the Tohoku region.

Evan S. INGRAM is Assistant Professor of Japanese Studies at the Chinese University of Hong Kong. His research interests include the impact of Song-period Chinese religion on Japan, the development of Pure Land Buddhism, and the organization of lay Buddhist societies.

Adam LYONS is Postdoctoral Fellow at the Kyoto Consortium for Japanese Studies. His primary research area is religion and society in Japan, and his book about the Japanese prison chaplaincy is under contract with the Harvard University Asia Center Press. He is also working on historical and ethnographic studies of Tenrikyō and religious social welfare work in Japan.

James Harry MORRIS completed his doctoral studies at the Centre for the Study of Religion and Politics at the University of St Andrews, Scotland in 2018. His research has focused on the history of Christianity in Japan, Christian-Muslim relations in East Asia, Japanese New Religious Movements, and religious conversion. He is currently Assistant Professor at the University of Tsukuba, Japan.

Inken PROHL is Professor of Religious Studies at Heidelberg University. She has conducted fieldwork in Japan and Germany for several years. Her research interests focus on modern transformations of Buddhism, new approaches to “Material Religion,” as well as religion and consumption. She is the author of *Religiöse Innovationen: Die Shintō-Organisation World Mate in Japan*.

Paul L. SWANSON is Permanent Research Fellow at the Nanzan Institute for Religion and Culture and co-editor of the *Japanese Journal of Religious Studies*. He is the author of *Foundations of T'ien-t'ai Buddhism* (Asian Humanities Press), *Clear Serenity, Quiet Insight* (Hawai'i), and *In Search of Clarity* (Chisokudo). He will retire from Nanzan University in 2020.

George TANABE is Professor Emeritus at the University of Hawai'i and has authored, co-authored, or edited books that include *Myōe the Dreamkeeper* (Harvard), *Practically Religious* (Hawai'i), *Religions of Japan in Practice* (Princeton), *Sources of Japanese Tradition* (Columbia), and *Japanese Buddhist Temples of Hawai'i* (Hawai'i). In 2012 the Japanese government honored him with the Imperial Order of the Rising Sun. He is currently the president of BDK Hawai'i and BDK America.

Richard TORRANCE is Professor of Japanese in the Department of East Asian Languages and Literatures at Ohio State University, where he specializes in Meiji-era literature and the literature of naturalism. He is the author of *Tokuda Shūsei and the Emergence of Japan's New Middle Class* (University of Washington Press, 1994) and has translated works by Tokuda Shūsei and others. He is currently working on a cultural history of the Izumo region.

Aihua ZHENG is Visiting Assistant Professor in the Departments of Religious Studies and History at the University of Iowa. She has authored articles on modern Japan, comparative and transnational studies of Japanese religion and culture, and Buddhism in the modern world. She is currently working on a manuscript on Shaku Sōen and the Rinzai school in East and South Asia and North America.
